## Professional Liability Insurance

Every year, actual or threatened litigation costs school administrators thousands of hours and dollars. To reduce your vulnerability and allow you to concentrate on what you do best--the following options are available:

LAP - All Active Members of the Association are eligible for Professional Liability Coverage with limits of up to \$1,000,000 per claim. This coverage is in excess only over any coverage provided by the school board of which the member is employed.

### WHAT THE POLICY PAYS

- ◆ **COVERAGE A**--Up to **\$1,000,000** per Insured, per occurrence/**\$3,000,000** per occurrence, plus the cost of defense, investigation and legal fees. \*
- ◆ **COVERAGE B**--Up to **\$5,000** per claim, per Insured. Coverage for criminal proceedings and/or sexual misconduct limited to **\$10,000** aggregate per Insured, per policy year. Reimbursement of attorney fees are covered up to **\$165**/hour.
- ◆ **COVERAGE C**--Up to **\$1,000** premium on bail bonds.

**\*Note:** The duty of the insurer to defend extends even to groundless, false and frivolous suits or accusations.

### Membership Categories

**Individual Membership:** Available to principals, assistant principals, and other school administrators. Individuals receive all LAP benefits. This nontransferable membership is owned by the individual.
